This author's agreement (the "Agreement"), to be completed by prospective authors upon submission to the journal **Pathfinder: A Canadian Journal for Information Science Students and Early Career Professionals** (hereafter referred to as "*Pathfinder*"), is made effective on the date of \_\_\_\_\_\_\_ (the "Effective Date"). The Primary Author also represents the Co-Author(s), if any, listed above for all terms of this Agreement.

The following sections provides the terms of the Agreement between the author(s) listed above (the "Author") and the editorial team of *Pathfinder* (the "Publisher"), which includes any and all editorial team members from the Effective Date onwards, and governs the above-stated proposed article (the "Work").

# **Terms of Agreement**

#### Section 1: Author's Grant of Rights

In consideration of the Publisher's agreement to publish the Work in *Pathfinder*, the Author hereby grants to the Publisher the following:

- 1.1 The irrevocable and royalty-free right to publish, reproduce, publicly display, and distribute the Work in perpetuity throughout the world and in all means of expression by any method or media now known or hereafter developed, including, but not limited to, print and electronic format;
- 1.2 The irrevocable and royalty-free right to use the Author's name and likeness and association with the Work in published form and in advertising and promotional materials related to the Work; and
- 1.3 The irrevocable and royalty-free right to license others to do any or all of the above.

#### Section 2: Prior Publication & Publication by Others

- 2.1 The Author agrees not to publish the Work, or authorize any third party to publish the Work, whether in print or electronic format, prior to publication of the Work by the Publisher.
- 2.2 The Author agrees not to publish the Work in any journal which is substantially similar to *Pathfinder* for a period of one (1) year after the date of publication of the Work in *Pathfinder*.
- 2.3 Should the Author publish or distribute the Work elsewhere at any time or in any alternate format, the Author acknowledges and agrees to make reasonable efforts to ensure than any such additional publication cites the publication in Pathfinder by author, title, and publisher, through a tagline, author bibliography, or similar means (the "Pathfinder Credit"). For example, such Pathfinder Credit may be:

"Reprinted with permission from the author. Originally published in Pathfinder, Vol. X, No. X, <u>pathfinderjournal.ca</u>."

#### **Section 3: Editing and Formatting**

The Author authorizes the Publisher to edit the Work and to make such modifications as are technically necessary or desirable to exercise the rights in Section 1 for different media and

formats. The Publisher will make no material modification to the content of the Work without the Author's consent.

# Section 4: Author's Ownership of Copyright and Reservation of Rights

- 4.1 Nothing in this Agreement constitutes a transfer of the copyright by the Author, and the copyright in the Work (including the moral rights) is subject to the rights granted by this Agreement.
- 4.2 The Author retains the following rights, including, but not limited to, the right to:
- 4.2.1 reproduce and distribute the Work and to authorize others to reproduce and distribute the Work, in any format.
- 4.2.2 post a version of the Work in an institutional repository or the Author's personal or departmental web page so long as the version of the Work includes Pathfinder Credit (see Section 2.3).
- 4.2.3
  include the Work, in whole or in part, in another work, subject to Section 2 above and provided that Pathfinder is cited as the source of first publication of the Work (see sample Pathfinder Credit under Section 2.3).
- 4.3 The Publisher (as well as the Editorial Board of *Pathfinder*) strongly encourage contributors to *Pathfinder* to publish the Work under a Creative Commons Attribution 4.0 International License (**CC BY-NC-SA 4.0**) that allows others to distribute, remix, tweak, and build upon the Work as long as they credit the Author for the original creation.
- 4.4 Alternatively, the Author may choose to have their Work distributed under any of the Creative Commons licenses currently available (see <u>the Creative Commons</u> <u>Licenses list</u> for a description of each license).

### Section 5: Author's Representations, Warranties, and Undertakings

The Author represents and warrants that:

- 5.1 The Author is the sole author of the Work (or if a joint author, that the Primary Author has identified within the Work the other Co-Author[s]), and holds the copyright, either solely or jointly, and has the power to convey the rights granted in this Agreement.
- 5.2 The Primary Author is eligible to submit their Work to *Pathfinder* because the Primary Author is:
- 5.2.1 a student currently enrolled in a Canadian LIS program, library tech program, or other LIS-related degree programs; or
- an early career professional who graduated within the last two years from:
- a Canadian LIS program, library tech program, or other LIS-related degree program; or
- a non-Canadian LIS program, library tech program, or other LIS-related degree program, and is now currently working at, or is otherwise affiliated with, a Canadian institution.
- 5.3 As long as the requirements of Section 5.2 are satisfied (i.e. the Primary Author meets the eligibility criteria), the listed Co-Author(s) need not be held to the same criteria.
- 5.4 The Work has not previously been published, in whole or in part, except as follows:
- 5.5 Any textual, graphic or multimedia material included in the Work that is the property or work of other(s) is either explicitly identified by source and cited in the Work or is otherwise identified as follows:
- 5.6 To the Author's best knowledge, the Work does not contain matter that is obscene, libelous, defamatory; it does not violate another's civil rights, right of privacy, right of publicity, or other legal right; and it is otherwise not unlawful.

- 5.7 To the Author's best knowledge, the Work does not infringe the copyright or other intellectual property or literary rights of another.
- The Author acknowledges and understands that the Author is responsible for ensuring that the Work does not contain any statements that may be or are misleading, fraudulent, libelous, defamatory, infringing, plagiarizing, or otherwise unlawful.
- 5.7.2 The Author acknowledges and understands that the Publisher shall only review the Work according to the policies, procedures, and steps explicitly provided in the Publisher's internal documentation, and that further review of the Work and its lawfulness beyond such policies, procedures, and steps shall not be provided unless agreed upon in writing.
- The Author acknowledges and agrees that the Publisher is not responsible for any statements contained within the Work that may be or are found to be misleading, fraudulent, libelous, defamatory, infringing, plagiarizing, or otherwise unlawful.
- 5.8 The Author will indemnify and hold Publisher harmless against loss, damages, expenses, awards, and judgments arising from breach of any such representations and/or warranties set out in this Section 5.

# Section 5: The Reuse of Third-Party Works

The Publisher requires that the Author determine, prior to publication, whether it is necessary to obtain permissions from any third party who holds rights with respect to any photographs, illustrations, drawings, text, or any other material (the "Third-Party Work") to be published with or in connection with the Work. Copyright permission will not be necessary if the use is determined to be fair dealing, if the Third-Party Work is in the public domain, or if the rights-holder has granted a Creative Commons license or other such license. If either the Author or Publisher determines for any reason that permission is required to include any Third-Party Work, the Author will obtain written permission from the rightsholder and provide such permission to the Publisher.
